- The School/Institution shall produce an undertaking to the effect that it shall follow the provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act, 2017 and the rules made there under.
- The School shall upload their data to U-DISE System (Unified District Information System for Education) and update it regularly.
- In case of any breach or contravention of any of the provisions of the Affiliation, bye laws of the respective Board or any provisions of the Gujarat Self-financed Schools (Regulation of Fees) Act-2017, and the rules made thereunder or any of the conditions of the NOC, State Government reserves its right to withdraw the NOC.
